



## Jeffries will 'opt-out' on warehouse guidelines

### Supervisor not pleased with watered down version of Good Neighbor Policy

With three warehouse projects either approved or planned in Temescal Valley, we've closely monitored a proposal by **Supervisor Kevin Jeffries** to establish a **Good Neighborhood Policy** that would set standards for warehouses being built in unincorporated county areas.

The guidelines would take into consideration possible impacts – including noise, glare, traffic and air pollution – that such projects may have on nearby residents and other sensitive receptors such as schools and parks.

But when the guidelines were presented at the Nov. 19 **Board of Supervisors** meeting, targeting industrial/manufacturing buildings larger than 250,000 square feet with more than 20 loading bays, they were not as Jeffries had envisioned.

Jeffries objected to the 300-foot buffer called for between warehouses and homes instead of the 1,000 feet he had proposed. Additionally, **Supervisor Jeff Hewitt** tacked on to the approval motion the ability of each supervisor to opt-out from having the policy apply to their district, making the standards not uniform throughout the unincorporated areas. The policy passed on a 3-2 vote with Jeffries and **Supervisor Chuck Washington** dissenting.

Thus far, Jeffries and Hewitt are the only two supervisors who say they will not apply the guidelines in their district but will review warehouse projects on a case-by-case basis.

Industrial/manufacturing projects planned for Temescal Valley include the 477-acre **Serrano Commerce Center** approved by the county in June 2010. The property is on the east side of the I-15, stretching south from the former Rinker Materials property to Temescal Canyon Road near **Terramor**.

**Proficiency Capital** now is in planning discussions with the county about building an industrial complex on the about 70-acre site of the former Hydro Conduit/Rinker Materials pipe plant which it is purchasing from the **Deleo Family**. The property is at Dawson Canyon and Temescal Canyon roads.

Finally, owners of the yet-to-be constructed 355-home **Renaissance Ranch** development approved by the county in 2005 are examining the possibility of making the 157-acre property an industrial complex. The change in land use would require a new set of approvals by the county. The property is adjacent to the **Horsethief Canyon Ranch** community in the area where De Palma Road dead-ends at Horsethief Canyon Road.

Here's what Supervisor Jeffries had to say about the Good Neighbor Policy in the Kevin's Corner comments of his December **Jeffries Journal** newsletter:

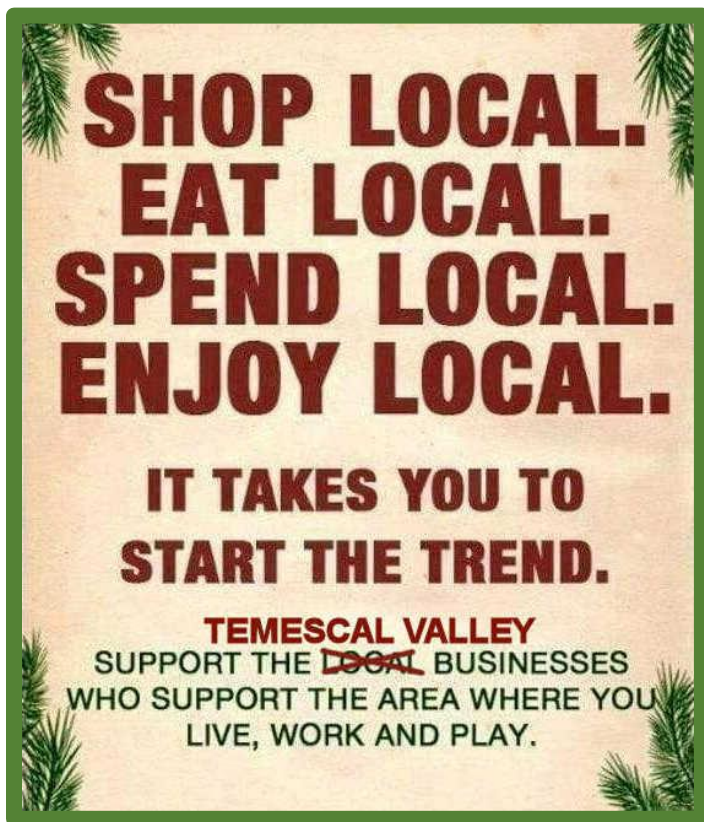
*"Warehouse Vote Gets Complicated. About two years ago, our office and the Riverside County Planning Department embarked on an ambitious proposal to develop some uniform standards for new proposed warehouses in the unincorporated territories.*

*"The County looked for other cities and agencies that had "Good Neighbor" guidelines in place and found very little that had actually been adopted. While owners of property zoned Industrial have a right to propose projects, one of my goals has been to protect the property rights on both sides of the fence, to make sure the voices of the existing homeowners who suddenly found themselves with a new large warehouse being proposed immediately adjacent to their home had an equal voice in the process.*

*"Unfortunately, I've been on the losing side of numerous mega-warehouse votes, as I felt that looking out your kitchen window at a 30 or 40 foot tall building wall, or listening to tractor trailer rig backup alarms all night, the glare of warehouse loading bay lights in your windows, and the local traffic impacts of all the trucks was not fair to impose on adjacent residents.*

*"After many delays, and opposition letters from the warehouse industry, the final proposal was presented last month by Planning staff to my fellow Board Members. It did NOT go well (for residents, at least). In fact, I think you could argue that the industry enjoyed an incredible victory that they did not even plan for.*

*"The proposed design standards actually contained a number of good items as far as sound walls, heavy and mature landscaping, and traffic flow restrictions (to name a few). However, the distance requirement between the heavy trucks and homes called for a much lower standard than I was comfortable with, and the real kicker that was contained in the motion that passed 3-2, was that each Supervisor would have the right to opt-in or opt-out of the standards as he/she sees fit. I voted no. From my point of view, having optional standards was NOT leveling the playing field for nearby homeowners to have an equal voice and to make sure they could sleep at night."*

## FERC tells Nevada Hydro to give Forest Service info needed for EIS

The **Federal Energy Regulatory Commission (FERC)**, was expected to soon issue a **Notice of Intent (NOI)**, to prepare an **Environmental Impact Statement (EIS)**, for **Nevada Hydro Company's Lake Elsinore Advanced Pumped Storage (LEAPS)**, project.

The NOI usually includes dates of scoping meetings where details of the project are presented and the public can ask questions and offer comments, but it now appears the NOI will be delayed.

The **U.S. Forest Service** in October let FERC know it did not have sufficient information from Nevada Hydro to work jointly with other Federal agencies in compiling its environmental data.

FERC, in a Nov. 22 communication, informed Nevada Hydro that withholding the needed information could result in the Forest Service having to develop a supplemental EIS at a later date, which would be inconsistent with the intent to have a single environmental document that supports each agency's permitting decision.

FERC told Nevada Hydro before it issues the NOI, "Nevada Hydro must consult with the Forest Service to develop a plan and schedule for providing the requested information and file monthly progress reports with the Commission on the status of the consultation and development of the additional information."

The committee also hopes to work more closely with the county's **Code Enforcement Department** to remove a criminal element of "squatters," who live on privately-owned property in conditions that don't meet county codes.

The first goal of the **Business Committee**, with **Wildrose Ranch** residents **Glen** and **Kelly Nelson** at the helm, is to compile a **Business Directory** featuring only Temescal Valley businesses.

The directory will list, by category, both storefront and in-home businesses. Information on how to be included in the directory will be published and emailed in early January.

## RV-storage facility OK'd by county

What for years has served as an illegal Temescal Valley dumping ground and community eyesore, a 7.69-acre parcel on Temescal Canyon Road south of Hostettler Road will soon be developed.

At a **Planning Director's Hearing** held Monday, the county approved a proposal from property owner **Rancon Group** to build a public storage and RV facility on the east side of Temescal Canyon road across from the **Temescal Canyon Rockery**.

**Ranch RV & Self-Storage – Temescal Valley** will be similar to the public storage business Rancon opened in August 2018 in Murrieta on Briggs Road near Winchester Road.

Planned for the estimated \$17 million Temescal Valley project are 1,304 storage units and a 32-space RV storage area. The project will be built in two phases with 652 units planned for the first stage and 652 units in the second phase.

The development will have walls ranging from 8 to 12 feet in height that allow no visibility of the units along the perimeter of the project. Two 38-foot tall buildings are planned for the center of the development and a 26-foot tall office building will be located on the north end. Improvements will be made to Temescal Canyon road and landscaping on 27 percent of the property will include several mature trees and shrubs.

Rancon anticipates opening the facility in 15 months if the county agrees to allowing improvements made to the road, plus the construction of a temporary road and grading for the project to occur simultaneously.

According to Rancon representatives, the site is visible from the I-15 freeway and will have easy access from the Lake Street off-ramps, and new housing development in the area justifies the need for more storage facilities.

“We will do a great job building a building the community can be proud of,” said Dan Stephenson, Rancon founder and chairman.

## CNUSD's Rozzi to be arraigned Dec. 20

**Ted Rozzi**, the former **Corona-Norco Unified School District** assistant superintendent of facilities charged with 30 felony counts of allegedly embezzling **\$2.6 million** of public funds from the district, is scheduled to be arraigned **Friday, Dec. 20**.

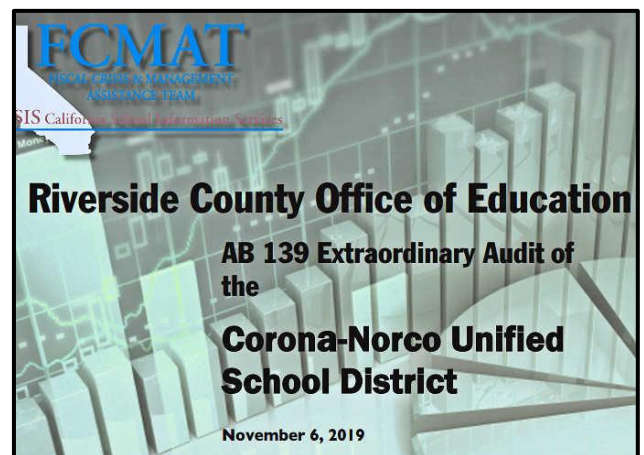
**Edward Mierau**, chief executive officer and chief financial officer of **Neff Construction**, who has been charged with 27 felony counts for allegedly assisting Rozzi, is scheduled to be arraigned **Friday, Jan. 3**.

The two are accused of a scheme that diverted school construction funds paid by Neff into personal banking and credit card accounts held by Rozzi.

The independent audit of the district by the state's **Fiscal Crisis & Management Assistance Team**, ordered by **County Superintendent of Schools Judy White**, has exhibits illustrating evidence of fraud and the misappropriation of funds.

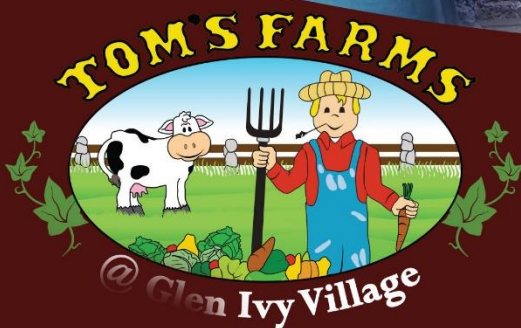
