## Midyear opening seen for condominium development

**Serrano**, the 80-home condominium community under construction at Temescal Canyon and Campbell Ranch roads, should open for sales midyear according to builder **Taylor Morrison**.

The three- and four-bedroom, two-story homes will range in size from 1,732 square feet to 2,238 square feet with four floor plans available. The sales price hasn't yet been announced.

The lots should be low-maintenance with small front and back yards because of the layout of the community. Serrano will feature a motor court architecture -- eight units will be arranged with front doors and garages facing a common stub street or driveway accessed from the development's main streets.

According to the Taylor Morrison website, the homes will be environment-friendly with standard features such as whole-home air filtration, smart thermostat innovations, hands-free kitchen faucet, water filtration in every kitchen and low VOC paint. In its approval of the development, the county required an air filtration system in the homes because of their proximity to the freeway.

Serrano will be an HOA community with fees anticipated to be \$368 at buildout. Amenities offered are a recreation center that includes a pool, a tot lot/playground area, and a passive park. In addition to the common area landscaping and recreation facilities, the HOA will be required to maintain the wash area and the slopes descending into the wash.

The proposed development met with much community opposition when the property owners sought county approval in 2018. Primary objections were the project's density, firefighting concerns, and one road for access to and from the development. The safety of children walking to and from school was questioned, as well as the proximity to adjacent mines and the I-15, and the creation of more traffic on area streets.

Supervisor **Kevin Jeffries** agreed with his constituents but was out-voted by the other four supervisors, all who had political connections to the developer. Jeffries later said, "It was sad to watch my fellow Board members openly side with the developer's desires over my concerns for the community."

## DON'T MISS THE TOWN HALL!

According to **Jeff Greene**, Supervisor Jeffries' chief of staff, "Virtual attendance will be a nice option, but all the best conversations in the room are the questions and answers individuals can ask at nearly every county department's table."

# ROZZI BEGINS TWO-YEAR PRISON SENTENCE

## Former CNUSD administrator repays almost all \$1.1 million embezzled between 2011-2017

Former **Corona-Norco Unified** Assistant Superintendent **Ted Rozzi** on Friday, April 1 was sentenced to two years in prison after admitting he stole more than \$1 million from the school district over several years.

Last July, Rozzi pleaded guilty to embezzlement by a public officer and misappropriation of public funds. He was sentenced to two years on each count, but the prison terms are to be served concurrently. The plea agreement also required him to pay back prior to sentencing the \$1,176,956.50 he stole from the district between January 2011 and May 2017.

In court last Friday, Rozzi had a check for \$519,298.13 which was given to **Judy Now**, CNUSD's chief of staff who was in court to give the district's victim impact statement.

According to an April 1 story in **The Press-Enterprise** by staff writer **Brian Rokos**, "Rozzi has also committed to paying the district \$41,231 from a bank account that the judge unfroze on Friday. Rozzi previously paid the district \$503,264, district spokesperson **Brittany Ritzi Foust** said. Deputy District Attorney **Matt Murray** told the judge that Rozzi will still owe the district approximately \$113,170."

The plea agreement requires the remainder owed to be repaid as part of Rozzi's probation when he is released from prison.

At the time of his arrest, the court seized property he owned including a home in San Diego. A receiver was appointed to sell the San Diego property with the proceeds used to provide the \$1 million in restitution.

With \$1 million repaid to CNUSD, the district will return the \$1 million settlement it received from its insurance company.

In reading the district's victim impact statement, Judy Now told the court, "His devious and unethical actions have caused immeasurable damage to CNUSD, and his shameful misconduct will forever leave a stain on the reputation of our District."

Rokos said after Rozzi was sentenced, he was led away by a sheriff's deputy. He said Rozzi did not make a statement on his behalf, but in an interview afterward, Rozzi's attorney told Rokos his client was remorseful.

The court months ago dismissed all charges against **Edward Curtis Mierau**, the CEO of **Neff Construction** who, with Rozzi, was arrested in November 2019. The two were accused of a scheme that diverted school construction funds paid by Neff into personal banking and credit card accounts held by Rozzi. At the time, both were released on their own recognizance.

In the July plea agreement, Rozzi exonerated Mireau of any complicity in the crime. He wrote, "Between Jan. 10, 2011 and May 12, 2017, I fraudulently, willfully and unlawfully appropriated and embezzled \$1,176,956.50 of public monies belonging to CNUSD for my own personal use without authority of law. I accomplished this ... by abusing the trust of CNUSD, Neff Construction and Neff Construction CEO Ed Mierau."

According to Rokos in response to a question asked on Facebook, Mireau remains as CEO of Neff Construction. He sued the auditors who assisted the sheriff's department with the investigation that implicated him in the embezzlement. He lost his case but has appealed.

Evidence of the embezzlement was discovered in May 2017 by a CNUSD employee who noticed a suspicious transaction between Rozzi and Neff Construction. She reported it to the Riverside County Sheriff's Department and an investigation ensued. Rozzi was placed on administrative leave Aug. 11, 2017 and resigned three days later.

The investigation into the matter by District Attorney **Mike Hestrin**'s office was lengthy, and the charges were not filed and the arrests not made until November 2019. The district, in the meantime, told the public Rozzi had retired.

Hestrin, in the initial announcement of the crime, had placed the amount at \$1.1 million. The results of an independent audit conducted by the state's **Fiscal Crisis Management Team** at the time of Rozzi's resignation indicated there was sufficient evidence that \$2.6 million may have been embezzled. Hestrin's office also worked on the audit.

People have questioned why Rozzi only had to repay \$1.1 million instead of \$2.6 million. Apparently, there was not "sufficient evidence" to support the entire \$2.6 million amount. Rozzi's attorney **Eric D. Anderson** told The P-E's Rokos that the \$2.6 million the state fiscal people estimated Rozzi stole was a "ridiculous" figure and was wrong.

People also question how Rozzi could have embezzled that much money over that length of time. According to the P-E story, the state audit also "showed that the district failed to follow its policies and that its internal controls allowed Rozzi to operate with little oversight."

The state audit was requested by then County Superintendent of Schools **Judy D. White** and required CNUSD to submit a report to the **Riverside County Office of Education** outlining the changes made to ensure sound fiscal practices.

The CNUSD board submitted those changes in November 2019. They are:

- Moved the Facilities Department under the direction and oversight of Assistant Superintendent of Business Services.
- Standardized the fiscal oversight in Facilities to be consistent with district practices.
- Moved all procurement functions away from the Facilities Department and into the Purchasing Department.

Rozzi was a 27-year employee with the district. **Dr. Samuel Buenrostro**, CNUSD superintendent, said the district checked with **CalPERS** to determine how the pension would be managed.

Under the **California Public Employees' Pension Reform Act of 2013**, Rozzi will lose 6.543 years of service credit accrued for the period from when the embezzlement began -- January 2011, until the district terminated him -- May 2017. He paid into his retirement and will not lose the amount he paid.

## State-of-the-art facility will feature 1,300 units at buildout next month

**Ranch RV & Self-Storage** has opened Phase I of its new facility in Temescal Valley at 14500 Temescal Canyon Road.

According to **Celeste Ducharme**, Ranch Self-Storage's vice president, rentals have been brisk, averaging two a day since the March 1 opening.

At complete build-out expected late April-early May, the state-of-the-art facility will offer 1,300 units totaling over 215,000 square feet of storage space, including many temperature-controlled spaces.

With the completion of phase II, a full selection of unit sizes will be available to meet a wide variety of needs. Additional spaces will include ground floor units as well as second- and third-story units with easy elevator access. Smaller units are being constructed now, but drive-up units are currently available ranging from 10' x 18' up to 10' x 29'. Parking to accommodate boats and RV storage will be fully available with the completion of phase II.

According to Ducharme, "We pride ourselves on our security measures." The facility features private gate code access through a touch display drive-through security gate. Restrooms can be found both indoors and outdoors.

The property's customer service office features a modern lobby equipped with the latest technology, including surveillance of the entire facility by 48 cameras. Also offered are packing and moving supplies and shredding services.

"We're also proud of our staff," Ducharme said. "Many of our customers are often experiencing a stressful time in their lives dealing with downsizing, a death in the family, divorce, or displacement. It's our team's mission as transition specialists to offer understanding and compassion to help our customers through what could be stressful time."

She said she appreciates all that the community endured during the construction – having to navigate the detour road at the same time Edison was placing the new powerlines and poles. She also noted Ranch Storage is very community-oriented and believes in giving back to the neighborhood.

# 396 calls for service in March are 43 more than in February

Lt. Sarah Mack, with the Lake Elsinore Sheriff's Station, has provided information on Part I crimes that occurred here during February and March.

The station received 396 calls for service from Temescal Valley during March – 43 more than received in February.

Thirty-four calls in March and 26 calls in February were for Part I crimes. No homicides or arsons were reported for the two-month period. Here's the breakdown:

**Assault – 4 in March and 4 in February.**

**Burglary – 3 and 4.**

**Grand/Petty Theft – 19 and 11.**

**Sex Crime – 2 and 0.**

**Robbery – 0 and 1.**

**Theft from Vehicle – 1 and 3.**

**Vehicle Theft – 5 and 3.**

**There were 12 arrests in March**

– seven felonies including two warrants, a possession for sale of a controlled substance, an assault with a deadly weapon, and three vandalisms. There were five misdemeanors including one warrant, two possessions of drug paraphernalia, a possession of methamphetamine for personal use, and a public intoxication.

**February saw five arrests** – all misdemeanors including two possessions of drug paraphernalia, a battery, and two domestic violence.

There were **six vandalisms** reported for March and **10** for February. **Disturbing the peace** calls numbered **37** for March and **29** for February.

## Fentanyl: What Parents Need to Know

### What is fentanyl?

Fentanyl is a synthetic opioid that is similar to morphine but is 50 to 100 times more potent. Although it can be prescribed by a doctor to treat patients with severe pain, it is also made and used illegally.

Illegal Fentanyl is sold as a powder, dropped onto blotter paper, put in eye droppers and nasal sprays, or made into pills that look like other prescription opioids. Occasionally, the powder is used in vaping devices typically used for nicotine or marijuana.

Some drug dealers are mixing fentanyl with other drugs. This is because it takes very little fentanyl to produce a high, making it cheaper to produce and distribute. This is risky because people taking drugs or vaping don't realize they might contain fentanyl, making overdose more likely.

If you think someone is having an overdose, call 911 immediately and wait with the person until help arrives. If you think your child is using fentanyl or other opioids, please contact your family physician or your school site counselor.

### Fast Facts:

- Opioids affect your brain – they affect areas of the brain that control pain and emotion, making it hard to feel pleasure from anything besides the drug.
- Opioids affect your body – they slow down the actions of the body, such as breathing and heartbeat.
- Opioids can kill you – Even a single dose of an opioid can cause your breathing to slow or stop; taking opioids with alcohol or sedatives increases this risk.
- Opioids are highly addictive. – People who regularly use opioids often develop tolerance, which means that they need higher and/or more frequent doses of the drug to get the desired effects.
- Opioid addiction is treatable – Please contact your family physician or your school site counselor for help.

### How to recognize a fentanyl overdose?

- Cannot be woken up or not moving
- Breathing slow or absent
- Discoloration of lips and nails
- Choking or coughing, gurgling sounds
- Cold or clammy skin
- Dizziness or disorientation
- Pupils extremely small

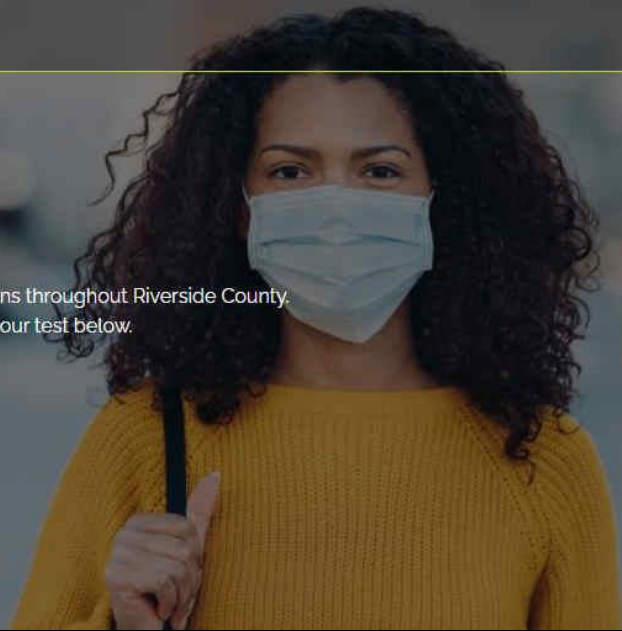
